ORDINANCE NO. 63

AN ORDINANCE ESTABLISHING PERMANENT GRADES ON  
PORTIONS OF KINGBIRD AVENUE AS HEREIN SPECIFIED

BE IT ORDAINED BY THE BOARD OF SUPERVISORS OF CERRO GORDO COUNTY, IOWA

SECTION 1. That for the purpose of regulating future construction in, upon or along the streets hereinafter designated, thereby, and the same is hereby established, a schedule of permanent grades in accordance with the elevations listed in Section IV hereof.

SECTION II. That said elevations conform to the U.S. Geological Survey (USGS) NAD 1983 Datum. And in particular to the bench marks listed on plans for Project No. L-626(18)--73-17, as prepared by the Cerro Gordo County Engineer's Office.

SECTION III. That previous ordinances or portions thereof in conflict with the elevations herein set forth are herewith repealed.

SECTION IV. That the centerline grade for Kingbird Avenue ends at station 13+83 which is the south edge of pavement of Highway 122.
