SUBJECT: Next Meeting – Thursday, April 4, 2024; 4:00 p.m.; Boardroom

Ladies and Gentlemen:

The next meeting of the Cerro Gordo County Planning and Zoning Commission is scheduled for **April 4, 2024 at 4:00 p.m., in the Boardroom at the Courthouse**. You will be considering one petition to vacate a platted street.

1. Christeven Schwarck, Anthony Schwarck, & Windy Oaks LC 12273 Spruce Avenue, Mason City, Iowa

Before you is a petition to vacate the platted 66' wide Front Street in the City of Hanford located on the property at 12273 Spruce Avenue, Mason City, IA (See Exhibit 1 (Petition) & Exhibit 2 (Vacation Plat). A portion of the dwelling and accessory buildings to the south are located within the platted Front Street (See Exhibit 3). The intent of the request is to allow for the private use of the land for the petitioners.

According to District Court records filed in 1930, the East Half of Block 1, all of Block 2, Main Street, the East Half of First Street, and Second Street were previously vacated (See color coded Exhibits 4 & 5). This 35+ acre parcel was for sale in the fall of 2023 and was purchased by the petitioners. The petitioners plan to sell approximately 5-6 acres including the building site (See Figure 6). The rest of the property will remain in ag production and owned by the Petitioners. During this process, the surveyor discovered that Front Street was never formally vacated.

Area utilities have been afforded the opportunity to provide comment. The Rockwell Coop Telephone Assn stated they have a fiber drop going to the house but did not state that they hold an easement in the platted street (See exhibit 7). United LP stated they have no easements on the property that would interfere with the plan to vacate Front Street. Any further comments received will be shared with the Commission at the hearing.

The County Engineer's Office has no concerns with vacating the public access. There are no public drainage structures within the platted street.

The standard established under Iowa Code 354.23 to vacate platted public right-of-way is the governing body must establish that there is no public benefit of the right-of-way. Front Street has been used as a personal driveway into the property for many years and has no access from Spruce

Avenue. It does not impact any legal access to another part of the property. We recommend the petition be forwarded to the Board of Supervisors with a recommendation of approval.







DECREE.

Now to-wit upon this 15th day of September, 1928, it being the 11th day of the regular 1928 term of the District Court of Cerro Gordo County, Iowa, the matter of the application of George S. Renshaw and Otto L. Stoltenberg to vacate a part of the town plat of Hanford comes on for hearing pursuant to an order of this Court entered in this cause September 96, 1925:

The petitioners George S. Renshaw and Otto L. Stoltenberg appearing by their attorney, Ralph S. Stanbery, no persons appearing to make objection to the granting of said petition and no objections thereto have been made.

And the Court now finds that the petition of George S. Renshaw and Otto L. Stoltenberg to vacate a part of the plat of the town of Hanford in Cerro Gordo County, Iowa was filed with the Clerk of this Court July 21, 1925 and that upon July 21, 1925, good and sufficient notice of the filing of said application was posted at the front door of the Court House in Mason City, Iowa and in three public places in the town of Hanford as shown by proof of such posting now on file in this cause. That upon the 6th day of September, an order was entered by this Court fixing Saturday, September 15, 1925 at 10 o'clock A.M., at the Court House in Mason City, Iowa as the time and place for hearing said application and that notice thereof be served as provided by Section 6285 of the 1927 Code of Iowa; that good and sufficient notice of the time and place of this hearing was published September 7, 1925 in the Hason City Globe Gazette as provided by law and as shown by proof now on file in this cause.

And the Court now hears the evidence and proofs offered by the petitioner and being fully advised in the premises, finds that upon the 15th day of September, 1928, the

petitioner, George S. Renshaw was the holder of the record title to the East Half (Et) of Block One (1) in the town of Hanford, consisting of Lots No. 1 to 20 inclusive, as laid out and platted in Section Six (6) Township Ninety-five (95) Range Nineteen (19) in Cerro Gordo County, Iowa; and that the petitioner, Otto L. Stoltenberg, was the owner of all of Block Two (2) of said town of Hanford; that the above petitioners are the sole owners of that part of the plat of the town of Hanford; that the above petitioners are the sole owners of that part of the plat of the town of Hanford wherein petioned to be vacated.

That the town of Hanford is an unincorporated village without indebtedness.

That the street known as Main Street, from the North line of First Street to the right of way of the Chicago, & Northwestern Railway is not needed for public use and that the street known as First Street, from the West line of Lot One (1) in said Block One (1) to the East line of Main Street is not needed for public use; That the street known as Second, from the West line of Lot Twenty (20) in said Block One (1) to the East line of Main Street is not needed for public use; that there are no lands lying within that part of said plat of the town of Hanford described by petitioners which has been dedicated or deeded to the public for parks or other public purposes;

It is therefore ordered, adjudged and decreed that the East Half of Block
One (1), all of Block Two (2). Main Street from the North line of First Street to
the right of way of the Onicego & Northwestern Railway, First Street from the West
line of Lot One (1) in Block One (1) to the East line of Main Street, and Second
Street from the West line of Lot Twenty (30) in Block One (1) to the East line of
Main Street in the town of Hanford as laid out and platted in Section Six (6)
Township Ninety-five (95) Range Nineteen (19) in Cerro Gordo County, Iowa, be,
and the same are hereby vacated, and the streets hereby vacated shall be and become the property of the adjoining land owners as provided by Section 5282 of the
1927 Code of Iowa. Decree to be entered on payment of costs.
