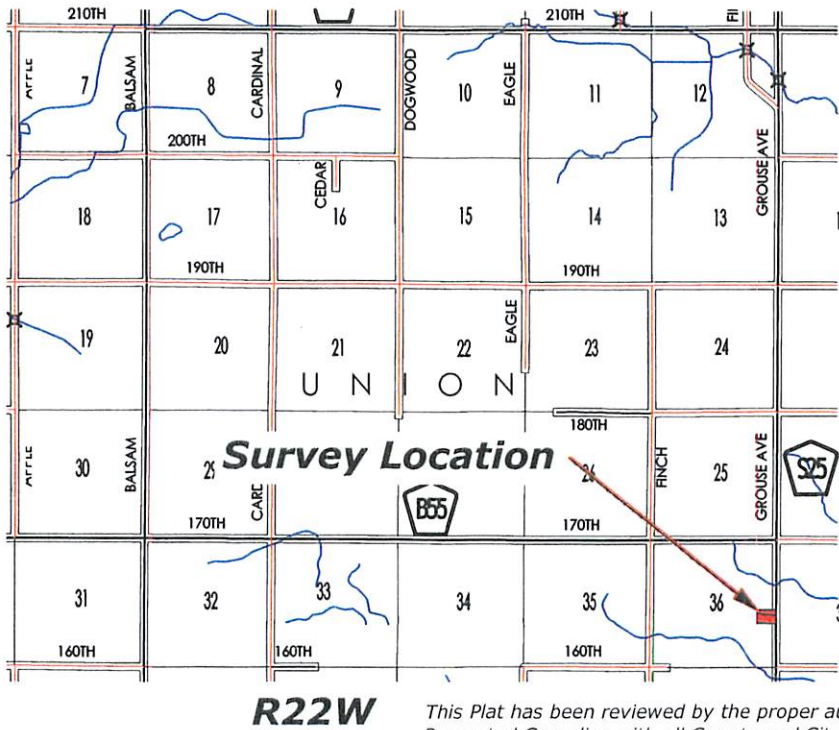

Control was acquired by localizing into the Cerro Gordo County GPS Control System utilizing Points 30, 33, 38, 122, 123, 124, 135, 136, 166 and 168 and projected from Point 123.

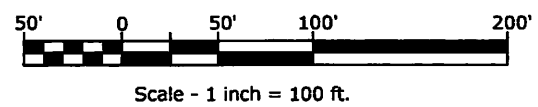

Red Tail Ridge, Cerro Gordo County, Iowa in the Northeast Quarter of the Southeast Quarter of Section 36, Township 95 North, Range 22 West of the 5th P.M., Cerro Gordo County, Iowa, and more particularly described as follows:

Commencing at the East Quarter Corner of said Section;

Thence **South 01°11'45" West, 294.27 feet** along the East Line of said Quarter-Quarter Section to the Northeast Corner of Parcel A, as recorded in Document #9801236, on file in the Cerro Gordo County Recorder's Office, Mason City, Iowa, and the Point of Beginning;

Thence continuing **South 01°11'45" West, 550.00 feet** along said East Line to the Southeast Corner of said Parcel A;

Thence **North 88°48'47" West, 791.75 feet** along the South Line of said Parcel A to the Southwest Corner thereof;

Thence **North 01°27'25" East, 550.20 feet** along the West Line of said Parcel A to the Northwest Corner thereof;

Thence **South 88°47'55" East, 789.24 feet** along the North Line of said Parcel A to the Point of Beginning.

Containing **9.98 Acres**, including 0.77 Acre of County Road S25 (Grouse Avenue) Right-of-Way, subject to any easements recorded or unrecorded.
