THEREFORE, BE IT RSOLVED, that the control of Drainage District 62, Cerro Gordo County, Iowa, is transferred to the City of Mason City, Iowa, and said transfer of control shall take effect on September 9, 2024. BE IT FURTHER RESOLVED, that a copy of this Resolution shall be certified to the City Council of the City of Mason City, Iowa and a copy of said certification and Resolution shall be filed in the records of Drainage District 62. Motion passed unanimously.

Callanan moved with Watts seconding, to approve job description for Election Clerk and approve the internal and external posting for Election Clerk position. Motion passed unanimously.

Callanan moved with Watts seconding, to authorize the Chair to sign Certificate of Appointment of Leah Karalius as Deputy Treasurer. Motion passed unanimously.

County Engineer Billings provided an update.

Callanan moved with Watts seconding, to go into closed session pursuant to lowa Code Section 21.5(1)(j) to discuss the purchase or sale of particular real estate only where premature disclosure could be reasonably expected to increase the price the governmental body would have to pay for that property or reduce the price the governmental body would receive for that property at 10:09 a.m. Roll call vote: Callanan – Aye; Watts – Aye; Meacham Ginapp – Aye.
