

PROCEEDINGS OF THE BOARD OF SUPERVISORS
June 2, 2025

The Board of Supervisors of Cerro Gordo County, Iowa, met in regular session pursuant to adjournment. Present: Chairman Chris Watts, Vice Chairman Casey Callanan, Supervisor Carl Ginapp, and various members of the public.

Chairman Watts convened the meeting at 10:00 a.m.

Ginapp moved with Callanan seconding, to approve today's agenda and the minutes of the May 27, 2025 regular session. Motion passed unanimously.

Callanan moved with Ginapp seconding, to approve claims. Motion passed unanimously.

Ginapp moved with Callanan seconding, to authorize the Chair to sign Fiscal Agent Agreement between the North Iowa Children's Alliance Board of Directors and Cerro Gordo County. Motion passed unanimously.

Callanan moved with Ginapp seconding, to approve reports from the Environmental Health Service Manager concerning Manure Management Plan Update for SunRay Pork Site 2 (site #65881) and SunRay Pork Site 6 (site #65852) and forward to the DNR. Motion passed unanimously.

County Engineer Billings provided an initial update.

The Board of Supervisors joined with Hancock County via phone at 10:15 a.m. for the Joint Drainage District 113/123.

Callanan moved with Rayhons seconding, to appoint Tyler Conley of Bolton + Menk as Drainage Engineer to review easement through Joint Drainage District 113/123 application. Motion passed unanimously.

Callanan moved with Ginapp seconding, to table item #11 – Consider Closure of Linden Street between Southshore Drive & Lakeview Drive. Motion passed unanimously.
