
Notification of Municipal Regulations and Hold Harmless Statement

It is further understood and agreed that the applicant shall at the option of the County, defend the County of Cerro Gordo, lowa, with appropriate counsel and shall further bear all costs and expenses, including the expense of counsel, in the defense of any suit arising hereunder.

Dear Sherry & Tim:

I am in receipt of your Temporary Use Permit/Application, for a block party in a residential district involving a street closure of Walnut Street from Southshore Drive to Lakeview Drive and live music from 6:00 p.m. to 9:00 p.m. on Saturday, August 16, 2025.

The permit has been approved with conditions. A copy of the Temporary Use Permit is enclosed. This permit is approved with the condition that all of the following requirements are met:

- You shall notify the County Sheriff's Department 24 hours before the event begins.
- A Work in the Right-of-Way Permit shall be received from the County Engineer's Office for the road closure, and all requirements for said permit shall be met.
- Proper trash receptacles shall be provided during the event, all refuse and solid waste shall be properly cleaned up at the end of the event.
- All live music shall stop at the end of the scheduled time consistent with the application.
- Lakeview Drive between Sycamore Street and Hackberry Street will not be closed and shall have no vehicles parked on the street or pedestrians sitting/blocking the street.
- No private driveways or private property shall be used or blocked in any way without the express permission of the property owner.
- Maintain the ability for all property owners on Walnut Street between Southshore Drive and Lakeview Drive to access their property as required under Article 22 (D)(2)(b)(5) of the Cerro Gordo County Zoning Code.

Upon a determination by the County Engineer, County Zoning Administrator or a County law enforcement officer that the applicant has failed to comply with any of the conditions set out above, the County official may cause the permit to be rescinded without notice and/or the street to be reopened.


