Our office has received a request from Bob Nuehring for right-of-way access within Drainage District 89. The request is associated with the proposed construction of a pig nursery located within the district.

The applicant has been informed that their application and supporting documents may be referred to a drainage engineer for review, and that any expenses related to that review will be the responsibility of the applicant. This review would focus specifically on evaluating the project's potential impact on the drainage district.

Given the scope of the project and its location within an established drainage district, I recommend that an engineer with expertise in drainage district matters be appointed to review the plans and provide a professional recommendation. Tyler Conley with Bolton & Menk has expressed interest in serving as the drainage engineer for this review, should the trustees choose to appoint him.



317.3 Weed commissioner -- standards for noxious weed control.

The board of supervisors of each county may annually appoint a county weed commissioner who may be a person otherwise employed by the county and who passes minimum standards established by the department of agriculture and land stewardship for noxious weed identification and the recognized methods for noxious weed control and elimination. The county weed commissioner's appointment shall be effective as of March 1 and shall continue for a term at the discretion of the board of supervisors unless the commissioner is removed from office as provided for by law. The county weed commissioner may, with the approval of the board of supervisors, require that commercial applicators and their appropriate employees pass the same standards for noxious weed identification as established by the department of agriculture and land stewardship. The name and address of the person appointed as county weed commissioner shall be certified to the county auditor and to the secretary of agriculture within ten days of the appointment. The board of supervisors shall fix the compensation of the county weed commissioner and deputies. In addition to compensation, the commissioner and deputies shall be paid their necessary travel expenses. At the discretion of the board of supervisors, the weed commissioner shall attend a seminar or school conducted or approved by the department of agriculture and land stewardship relating to the identification, control, and elimination of noxious weeds.

The board of supervisors shall prescribe the time of year the weed commissioner shall perform the powers and duties of county weed commissioner under this chapter which may be during that time of year when noxious weeds can effectively be killed. Compensation shall be for the period of actual work only although a weed commissioner assigned other duties not related to weed eradication may receive an annual salary. The board of supervisors shall likewise determine whether employment shall be by hour, day or month and the rate of pay for the employment time.

This report is to make you aware of concerns regarding a Manure Management Plan Annual Update received by this office from Bottlebrush Swine (Roger 1). This report is being submitted according to Resolution 2003-123 A Resolution Adopting Policy for the Receipt, Review and Comment on Manure Management Plans Received by the Cerro Gordo County Board of Supervisors. Within seven (7) days of receipt of the manure management plan the Environmental Service Manager shall review the Manure Management Plan and prepare a report to the Board of Supervisors detailing concerns to forward to the Iowa Department of Natural Resources.

The confinement unit is located at **1649 Vail Avenue**, **Klemme**, **Ell Township in <u>Hancock County</u>**. The swine operation is an existing operation that is not expanding. The operation has 2,400 hogs or 960 AU (animal units). The facility will produce 788,400 gallons of manure annually which will be stored in below-building pits.

The last review for this operation was conducted in 2021. Manure will be applied on seventeen fields totaling 2,279.52 acres. Seven fields are located in Cerro Gordo County in Sections 30 and 31 of Clear Lake Township and Sections 6, 18, 19, and 30 of Union Township. All the other fields/acres are in Hancock County. There is about a 2,000-acre reduction in the fields on which manure will be applied compared to the 2021 plan, however the Cerro Gordo fields are essentially the same. The concerns with the plan for Cerro Gordo County are listed below:

- Unincorporated Ventura Heights is about one mile the manure application area.
- The city of Ventura is about 11/4 miles from the manure application area.
- The heavily populated unincorporated areas of the south shore of Clear Lake are about 21/4 miles from the manure application area.
- Clear Lake (lake) is about 1¼ miles from the manure application area.
- Ventura Marsh Wildlife Management Area is about ½ mile from the manure application area.
- The Ventura Marsh Wildlife Management Area dredge ponds south of Ventura are adjacent to the manure application area.
- Blue Wing Marsh is about 1½ miles from the manure application area.
- Union Hills Wildlife Management Area is about 1¾ miles from the manure application area.
- Galls Creek dissects and runs adjacent to the fields in Section 18 of Union Township.
- A waterway cuts through the field in Section 19 of Union Township.
- Additionally, several of the Hancock County fields near the county line are in close proximity to Ventura Marsh Wildlife Management Area and the city of Ventura.

The confinement unit is located at **2498 180th Street, Klemme in Section 25 of Ell Township in <u>Hancock County</u> on the Cerro Gordo-Hancock county-line. Roger 2 hog site is an existing operation that is not expanding. The operation has 2,400 hogs or 960 AU (animal units). The facility will produce 788,400 gallons of manure annually which will be stored in below-building pits.**

The last review for this operation was conducted in 2021. Manure will be applied on seventeen fields totaling 2,279.52 acres. Seven fields are located in Cerro Gordo County in Sections 30 and 31 of Clear Lake Township and Sections 6, 18, 19, and 30 of Union Township. All the other fields/acres are in Hancock County. There is about a 2,000-acre reduction in the fields on which manure will be applied compared to the 2021 plan, however the Cerro Gordo fields are essentially the same. The concerns with the plan for Cerro Gordo County are listed below:

- Unincorporated Ventura Heights is about one mile the manure application area.
- The city of Ventura is about 11/4 miles from the manure application area.
- The heavily populated unincorporated areas of the south shore of Clear Lake are about 21/4 miles from the manure application area.

- A waterway cuts through the field in Section 19 of Union Township.
- Additionally, several of the Hancock County fields near the county line are in close proximity to Ventura Marsh Wildlife Management Area and the city of Ventura.


