

PROCEEDINGS OF THE BOARD OF SUPERVISORS
July 6, 2026

The Board of Supervisors of Cerro Gordo County, Iowa, met in regular session pursuant to adjournment. Present: Chairman Casey Callanan, Vice Chairman Carl Ginapp, Supervisor Chris Watts, and various members of the public.

Chairman Callanan convened the meeting at 10:00 a.m.

Ginapp moved with Watts seconding, to approve today's agenda and the minutes for the June 29, 2026 regular session and the June 30, 2026 special session. Motion passed unanimously.

Public comment session was held.

Watts moved with Ginapp seconding, to approve claims. Motion passed unanimously.

Ginapp moved with Watts seconding, to approve the payroll register for period ending 06/27/2026. Motion passed unanimously.

Watts moved with Ginapp seconding, to approve the Auditor's Quarterly Report of Fees and the Sheriff's Monthly Report of Fees. Motion passed unanimously.

Ginapp moved with Watts seconding, to adopt Resolution 2026-48, WHEREAS, House File 2490 Open Records and Open Meetings Laws was signed into law by Governor Kim Reynolds on May 15, 2026 amending Iowa Code Chapters 21 and 22 by modifying public meeting notice requirements. BE IT RESOLVED by the Cerro Gordo County Board of Supervisors as follows:

The Cerro Gordo County Board of Supervisors will post public meeting agendas on the bulletin board outside of the Cerro Gordo County Board of Supervisors office – 1st floor of the courthouse, the main doors of the Courthouse on the east side main entrance exit doors and the Cerro Gordo County Website (cerrogordo.gov) following the posting requirements. If an agenda that was previously posted needs to be amended, not less than 24 hours prior to the meeting, it will be marked with the word "Amended" and will identify the amended provisions. Motion passed unanimously.

Ginapp moved with Watts seconding, to appoint Mark Mathre to the County Board of Adjustment. Motion passed unanimously.

County Engineer Brandon Billings provided an update.

Watts moved with Ginapp seconding, to approve reports from the Environmental Health Service Manager concerning manure management plan update for Mike Kuhlemeier West Site (site #65997) and Neal Hog Farms LLC (site #69472) and forward to the DNR. Motion passed unanimously.

Ginapp moved with Watts seconding, to adjourn at 10:12 a.m. Motion passed unanimously.
